# 1. Purpose

The Parties intend to engage in discussions and/or services relating to Microsoft Dynamics 365, Power Platform (Power Apps, Power Automate, Power BI), and related digital consulting work. In connection with this, each Party may disclose to the other certain confidential or proprietary information.

## 2. Definition of Confidential Information

"Confidential Information" means all information, whether written, oral, or digital, disclosed by either Party that is designated as confidential or would reasonably be considered confidential given the nature of the information.

# 3. Obligations of Confidentiality

Each Party agrees to:

- a. Keep the Confidential Information private and not disclose it to any third party;
- b. Use the Confidential Information solely for the purpose outlined above;
- c. Take reasonable measures to protect the confidentiality of the information.

#### 4. Exclusions

This Agreement does not apply to information that:

- a. Is or becomes publicly available through no fault of the receiving Party;
- b. Was known to the receiving Party before disclosure;
- c. Is disclosed with prior written approval from the disclosing Party;
- d. Is required to be disclosed by law or court order.

## 5. Duration

This Agreement shall remain in effect for a period of **3 years from the date signed by both Parties.** 



#### 6. No License

Nothing in this Agreement grants either Party any rights in or to the Confidential Information except as expressly set forth herein.

# 7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. The Parties submit to the exclusive jurisdiction of the English courts.

# 8. Entire Agreement
